"THE ULTIMATE MATES TRIP" PROMOTION

TERMS AND CONDITIONS

- 1. Information on how to enter and the prizes form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.
- 2. The promoter is Stanley Black & Decker Australia Pty Ltd (ABN 82 000 021 938) of Level 2, 810 Whitehorse Road, Box Hill, 3128 ("**Promoter**"). The sponsor of this promotion is Super Cheap Auto Pty Ltd (ABN 64 085 395 124) of 751 Gympie Road Lawton QLD4501, Australia ("**Sponsor**").
- 3. Entry is open to Australian residents only aged 18 years or over, who can take the prizes, if draws as a winner, on the dates and as required in these Terms and Conditions. Entry is not valid for commercial transactions made by or on behalf of a business.
- 4.
