Terms and Conditions

1. Information on how to redeem your Weber BBQ is part of the terms of entry. Attempting redemption is deemed acceptance of these terms and conditions.
2. Redemption is open to all residents of Australia who meet the criteria. 13. Once the Weber BBQ has left the Promoter's premises, the Promoter takes no responsibility for damage, delays or lost in transit.
14. It is a condition of entry that the receiver must comply with all the conditions of use of the Weber BBQ Terms & Conditions.
